## **QUOTATION EXCLUSIONS – Ref. SD3**

The following are excluded from any Contract or Quotation, unless inclusion is specifically stated in writing. The additional cost of any exclusions can be quoted upon request.

<b>VAT :</b>	The prices exclude VAT which will be added at the prevailing rate.
<b>Delivery:</b>	Excludes Delivery charge to the customer premises
<b>Electrical installation:</b>	Electrical installation or field wiring
<b>Installation:</b>	Installation of goods or equipment
<b>Commissioning</b>	Commissioning of goods or equipment
<b>Installation:</b>	When installation is included it is based on uninterrupted access during normal working hours.
<b>Civils work:</b>	Civils work including all wall, boring, basic and concrete work e.g. clearance of installation site, including any overhead services, any necessary builders work to the installation area, etc.
<b>Location:</b>	The price quoted assumes clear and unimpeded access from the off load position to the installation position on a sound and level floor. It is the customer's responsibility to ensure that the floor is capable of withstanding any thermal and mechanical stresses imposed on it.
<b>Replacement Air:</b>	The performance of any air extraction equipment is dependent upon the replenishment of an adequate volume of replacement air into the workplace.
<b>Weatherproofing:</b>	Materials are supplied and fitted to provide a temporary weatherproofed wall seal.
<b>Positioning:</b>	The price quoted assumes the availability of necessary lifting gear needed to position the equipment (forklifts, cranes, etc.)
<b>Regulations:</b>	The products quoted are designed to comply with the latest Health & Safety regulations. However, it is the customer's responsibility to define any ATEX areas and requirements and to ensure that products and their installation comply with any local bylaws and regulations.
<b>Mains services:</b>	The price quoted assumes prior provision and connection of all necessary main services by the customer to the point of installation connection i.e. filtered compressed air supply, 24 mbar gas supply, water supply, drainage, and electrical supply.
<b>Building Work:</b>	Any building/roofing work involved in cutting holes, provision of anchor points, making good same or any form of sealing after ductwork installation
<b>Fire Protection</b>	Any fire protection that may be required
<b>Waste:</b>	Removal from site of waste generated during installation period
<b>Drains:</b>	The provision neither of any drains nor for the obtaining of any planning permission.

## **REQUIRED INSTALLATION CONDITIONS**

Unless otherwise stated in our proposal, we require the following conditions for site installation.

<b>Access Equipment</b>	Forklift, powered access platforms, ladders and scaffolds as required
<b>Electric Supply</b>	240 V / 3x415 V, 50 Hz close to the installation area
<b>Air Supply</b>	5-6 bars lubricated and clean compressed air close to the installation area.
<b>Access</b>	Free and un-interrupted access to the installation area
<b>Working week</b>	A 7-day work week; we must be allowed to worked on weekends or holidays as required
<b>Facilities</b>	Washing and changing facilities for our personnel
<b>Regulations</b>	The customer must in due time inform us of any regulations or laws beyond normal regulations
<b>EX Areas</b>	Classification of the EX areas (ATEX)
<b>Installation Area</b>	Flat and level installation area, clear of obstruction
